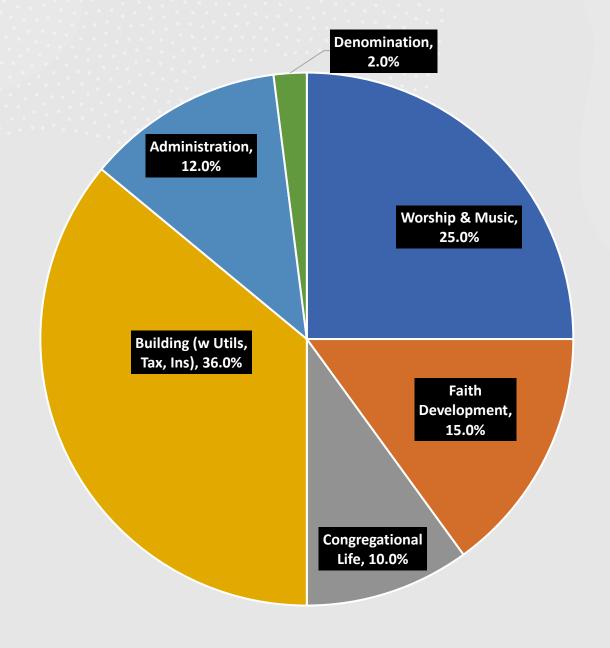

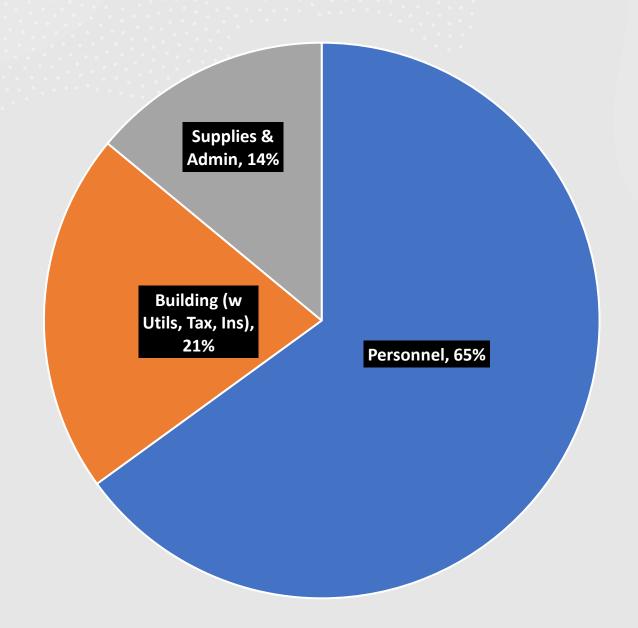
Where our Operating Funds Come From

(COLAs of 4.5% - 6% and raises plus health ins., FICA, and pension increases) \$65,000

• New position of Building Manager to take over

rental, event and building staff responsibilities from Garnett \$60,000 - \$70,000

• Various – Utilities, taxes, ins., supplies \$ 5,000

• Savings from decreasing Garnett to 4/5 time,

staff health ins. change, eliminating RE Assistant position -\$55,000

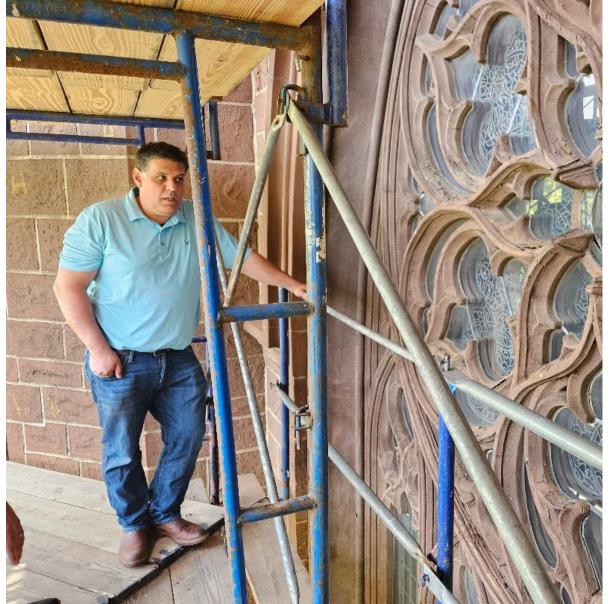


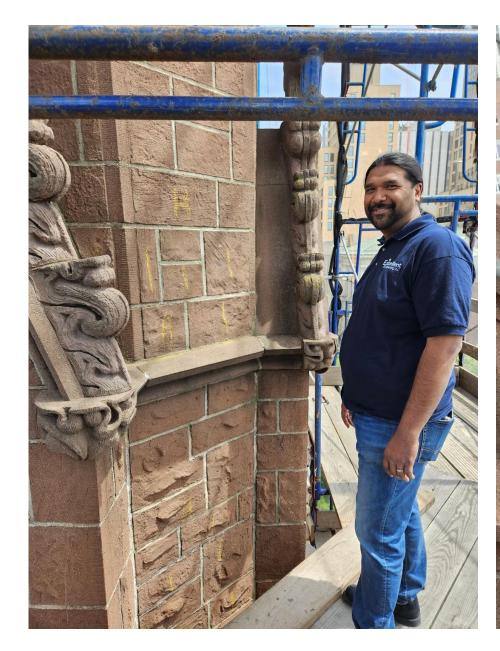
# Upcoming Projects
