



Goal: Earnings from the Fund will pay for maintenance and repair of facilities over 20 to 30 years.

Board created a schedule of maintenance and repairs with cost estimates and years.

Congregation created Fund in May 2019 with:

- \$400,000 transferred from General Endowment
- 10% of rental income from principal renters (app \$32,000 this year)
- Income from purchases of Green-Wood Cemetery plots (\$15,000 this year)
- Additional contributions

Work completed in:

- Sanctuary Narthex
- Chapel
- Undercroft
- Kitchen
- Library
- Green Room

Work Underway in:

- Sanctuary:
- Wheelchair Seating
- Stained Glass Windows
- Sound System
- Chapel/Undercroft Lift
- Chapel Facade





- Add to the Capital Reserve Fund, so earnings will cover projects for next 20-30 years
- Board will formally launch Campaign when we return to worshiping in Sanctuary
- Early contributions are welcome!
- 5 households have contributed \$23,000 since May 2020

National Events, September to Election Day

- Phonebank, Textbank and Postcard events tapping into the UUA network
- UUTV partners: New Florida Majority, Reclaim Our Vote, Showing Up For Racial Justice
- First U participated in 10 UU the Vote events contacting voters in FL, WI, OH, GA
- UUTV collectively made over 3M calls to voters in 2020!

Congregational Phonebank, October 25th

- UUTV partner: New Florida Majority
- 30+ participants called voters in historically marginalized communities in FL
- First U made over 16K calls in two hours!

Various / Next Steps

- Split the Plate: First U raised over \$700 for UU the Vote in October
- Georgia Runoff: UUTV organizing phonebanks in partnership with Reclaim Our Vote ahead of the January 5th runoff
