




Right Relations Covenant




CAPITAL REVIEW GROUP REPORT & MOTION









As we prepare to return to our spiritual home:

It is time to renew and repair our beautiful spaces









In 2019, the Congregation created a Capital Reserve Fund to provide for decades of Repairs

- Initial Funding
 - \$400,000 Segregated from the General Endowment
 - Capital Fund Campaign
- Ongoing Annual Contributions
 - ~\$45,000 From Operating Budget (10% of major rentals)
 - ~\$18,000 -- Earnings generated by the fund
 - Other Donations, bequests, etc.
- Initial catalog of Repairs for next 25 years
- Higher Repair costs in some years than others
 - Doesn't disrupt annual Operating Budget

Capital Fund Campaign

- Board charged Capital Review Group to update plan in 2021:
 - Identified 70 Repairs over the next 15 years, totaling \$1.5 million
 - Set the Capital Fund Campaign at \$500,000
 - Projected the Fund will have over \$500,000 remaining at end of 15 years, to carry us forward

- The Board endorsed the updated 15-year plan and the \$500,000 Capital Fund Campaign for Congregational approval at the Annual Meeting May 16
 - Reviewed at Budget Forum on April 18

Examples of Repairs and Renewal over the next 15 years

Repairs:

- Upgrade fire and smoke alarm
- Periodic organ repairs
- Repair foundations
- Replace boilers at end of life
- Repair windows, doors, skylights
- Safety, ecology, and accessibility

Improvements (FY22-23):

- Solar panels on the roof of 48 Monroe
- Ecological cooling and heating in the Chapel and Frances White Room

Resolution

- Whereas on May 19, 2019, the Congregation:
- Created a Capital Reserve Fund to perform projects listed in Appendix A,
- Provided for a Review Team to recommend updates to that project list within three years, and
- Authorized a capital campaign
- The Congregation therefore **Resolves** at the Annual Meeting May 16, 2021, to approve:
- The 15 Year Repairs Program published prior to the Annual Meeting, and
- A Capital Fund Campaign to raise \$500,000 for the Capital Reserve Fund.
