




















#### GOING FORWARD

- Additional spending between now and January
  - Estimated \$10,000 to determine scope of repair work, help obtain bids
  - Windows (\$18,000) for paint removal, planning structural reinforcement
- By January: more concrete estimates for facade stonework and window repair

#### BETH EVANS: ACTIONS OF IMMEDIATE WITNESS

- Every year at GA delegates vote to select three Actions of Immediate Witness or AIMs.
- An AIW is "a statement about a significant action, event, or development in the world that necessitates immediate engagement and action among UU member congregations and groups."

# ACTIONS OF IMMEDIATE WITNESS

- Dozens of AIMs are submitted each year, but only eight were presented for the vote this year.
- These three received the most votes for 2022:
  - We Do Not Consent: Rejecting Legal Challenges to Abortion (99 percent of delegates voted in favor)
  - Anti-Racism and Reparations via Restorative Justice (95 percent of delegates voted in favor)
  - Opposition to the Privatization of Medicare (77 percent of delegates voted in favor)
- The others touched on education, climate justice, international human rights, and labor.

# ACTIONS OF IMMEDIATE WITNESS

- If you want to learn more about the three current AIMs, google: actions of immediate witness 2022.
- The one related to Medicare is the most urgent because there is legislation coming up in Congress for a vote at the beginning of the new year.
- Google specific AIM to find out what actions YOU and the CONGREGATION can take (letter writing, educating, fundraising, being on the ground to show support and other ways to help).

## WORKSHOP: BREAKING THROUGH CLASS BARRIERS TO BUILD COMMUNITY

From the promo for the CA workshop:

Participants "explore the relationship between classism and inequality -- and understand that acknowledging and celebrating class differences is critical to growing connection within and across communities"

- The workshop was offered by a group that has coalesced under the banner, UU
  Class Conversation, and was modeled on the work done by the non-profit Class
  Action. UUCC began in 2013.
- Rev. Kimberly Quinn Johnson led the workshop at GA. She serves as minister of the Unitarian Universalist Congregation of the South Fork in Bridgehampton, Long Island and used to work as a union organizer with the United Auto Workers. In her own life she has moved among the different classes and has lived experience of how class affects perception and reception.

## QUOTING FROM REV. MARK W. HARRIS ON THE HISTORY OF CLASS IN UU CONGREGATIONS:

"compared to other religious groups, [UUs] ranked very highly in the 1990 National Survey of Religious Identification in terms of education levels, median income, home ownership, and suburban lifestyles. Our profile was an exact match for an L.L. Bean mailing list."

"How we could reconcile the rhetoric of a universal free faith with the reality of our present class-bound composition.... We need to make personal connections with all those who might find meaning in our liberal faith regardless of class background and promote a vision for the common good...."

"Do we welcome everyone to our congregations? — not just those who own their homes, but those who rent, those who suffer from mental illness, those who live in group homes, those who are lonely and need our caring friendship, those who have lost their jobs, have huge credit card debt, but also retired bank presidents, restaurant workers, and college professors, carpenters, and cab drivers. I think we will be more diverse than we have ever been before, as soon as we stop asking who belongs here or who is one of us."

#### FIRST UNITARIAN TAKE AWAYS

- We can offer the workshop (90 minutes, half day, full day) here in our congregation if there is interest.
- It really got people talking; a great beginning of an important conversation drawing on people's own experiences.
- It was fun! Eye-opening.

# JUSTIN PARKINSON: GENERAL ASSEMBLY TECH NOTES

#### First Multiplatform GA

- Participation was on-site and online for the first time, reimagining GA as a more equitable experience
  - Six on-site workshops live-streamed for online attendees
  - Three live on-line webinars also screened on-site
  - Sixty pre-recorded on-demand workshops, available to all attendees
  - On-site and online co-moderators/key speakers

# DWIGHT MATHIS: ARTICLE 2 STUDY COMMISSION

#### What is Article 2?

Article 2 is the section of the UUA by-laws that includes our mission statement, principles, and sources.

#### What's happening?

The UUA by-laws require that Article 2 is reviewed every 15 years. The Board appointed Article 2 Study Commission has been working on significant changes to the purpose statement and the principles. A draft has been made public and is available on the UUA website


#### What kind of changes?

If adopted, Article 2 will be changed significantly. The principles will be replaced with the Article 2 Purposes and Covenant.

# ARTICLE 2: SECTION C-2.1. PURPOSES.

The Unitarian Universalist Association shall devote its resources to and exercise its organizational powers for religious, educational, and humanitarian purposes. Its primary purposes are to equip congregations for vital ministry, to support and train leaders both lay and professional, to heal historic inequities, and to advance our Unitarian Universalist values in the world. We will transform the world by our liberating love.

- A final vote will be taken at GA 2024 (2/3 majority required to adopt changes)
