# PRESENTATION AND MOTION ON ACTION OF IMMEDIATE WITNESS AND RESPONSIVE RESOLUTION

#### BACKGROUND ON THIS VOTE

- A motion about the situation in Gaza was introduced by First Unitarian Young
   Adults at the May 2024 Annual Meeting of the congregation.
- Discussion about the motion became very heated both for and against the motion.
- A vote to table the motion was passed

#### THE UUA

**Unitarian Universalist Association** 

- UUs in "America"—Our values and roots go back to the 1600's: Human experience, freedom of thought, selfgovernment of congregations, drawing wisdom from many texts and sources, Beloved Community, racial justice, interconnectedness, Science as a guide to truth and meaning...
- Unitarianism and Universalism merged in 1961. Both denominations' heritages have been nurtured by the UUA to provide a strong voice for social justice and liberal religion.
- The UUA's General Assembly is attended by 2,500+ delegates, members, staff and clergy from 1,000+ UU congregations, each year.

# GENERAL ASSEMBLY (GA)

2024: Virtual (online) GA

- Business agenda is set by the UUA
   Board of Trustees
- Social Justice proposals can be initiated by delegates
  - 3 AIWs were voted onto the agenda in 2024
- Delegates from certified member congregations are able to vote
- GA has a set of rules and procedures to ensure the democratic process and right relations are maintained

- Every certified congregation is entitled to 2 delegates, plus 1 delegate for every 50 members over 100.
- First Unitarian had 6 delegates at last year's General Assembly, elected at the February 2024 congregational meeting
- First Unitarian's policy is to allow our delegates to vote their conscience.
- We elect our delegates from a slate presented by the Leadership Development Committee, after a comprehensive selection process. All members in good standing are eligible to be delegates.

# ACTIONS OF IMMEDIATE WITNESS

& Responsive Resolutions

An Action of Immediate Witness (AIW) is a statement about a significant action, event, or development in the world that necessitates immediate engagement and action among UU member congregations and groups.

- Actions of Immediate Witness (AIWs) express the conscience and carry the authority of the delegates at the GA at which it is passed. AIWs are initiated by individual delegates and move through their entire creation and adoption process during a single GA.

- There is extensive discussion, both live and on the delegate platform (written) before votes are held.

**Responsive resolutions (RR)** are brief, advisory statements that express the sentiment of the delegates.

# MOTION BY THE BOARD OF TRUSTEES

Be it resolved that the First Unitarian Congregational Society in Brooklyn affirms the Action of Immediate Witness: Solidarity with Palestinians & Responsive Resolution: UUA General Assembly Support for October 7 Hostages as adopted by delegates at the June 2024 Unitarian Universalist General Assembly.

#### Resolution

Be it resolved that the First Unitarian Congregational Society in Brooklyn affirms the Action of Immediate Witness: Solidarity with Palestinians & Responsive Resolution: UUA General Assembly Support for October 7 Hostages as adopted by delegates at the June 2024 Unitarian Universalist General Assembly.

- People are asked to speak for themselves, not for what they believe others may think. Also, people are asked to be mindful of the feelings of others in the way that they phrase their remarks.
- So that our on-line participants and those with hearing loss can participate fully, you must be at a microphone before being recognized to speak.
- Comments are limited to 2 minutes per person.
- The moderator will call on people with differing points of view alternately.
- No one will be called upon to speak for a second time before everyone wishing to speak has spoken once.
- Procedural questions, questions for information, and right relations/process questions will be addressed as soon as they are made known to the moderator, before calling on other speakers or moving on to another item of business.
- No vote on a motion will be taken before 15 minutes of comments have expired or there are no more people seeking to comment.
- After 15 minutes, the question may be called. A 2/3 vote is required to end debate and proceed to a vote on the motion.
- There must be a 2/3 vote to extend discussion beyond the time allotted on the agenda.

# FACILITIES COMMITTEE REPORT


### FACILITIES REPORT

- •Sanctuary designed by noted American architect Minard Lefever and erected in 1844
- •Exterior is brownstone, a porous material that cracks and spalls over time
- •Already repaired multiple times, most recently in 1995, 30 years ago
- •Inspection from scaffold in 2021 revealed extensive continuing deterioration
- •Will repair where needed along entire façade along Pierrepont St, from top to bottom




#### Laser Scan of Two Tall Spires – existing condition



# SCOPE OF CURRENT PROJECT

- Identify all deteriorated elements and specify how to repair or replace each of them – done
- Tailored repairs for three areas of the façade through summer 2025
  - Flat walls
  - Ornamentation below the roofline
  - Four spires above roofline
  - Each type of repair matches the color and texture of the existing brownstone
- After all repairs/replacements, wash surfaces and repoint mortar joints:
   summer/fall 2025
- Install lightning protection on two tall spires and along ridgeline of roof: summer/fall 2025
- Target to finish all repairs and remove scaffolding before Christmas 2025



### **FLAT WALLS**

- Remove cracked surfaces and repair with a longer-lasting approach than in 1995
  - Walls below roofline: done
  - Flat parts of four spires above the roofline: spring/summer 2025



# Ornamentation below Roofline

- Ornamentation below the roofline:
  - Remove deteriorated elements: done
  - Fabricate long-lasting "cast stone" (molded concrete) replacements: fall 2024 thru winter 2025
  - Install cast stone replacements: *spring* 2025




### SPIRES ABOVE ROOFLINE

- Surfaces near the roofline will be repaired the same way as the flat walls: spring/summer 2025
- Higher elements, which are more exposed and deteriorated, will be replaced with fiberglass
  - First-ever NYC Landmarks approval of fiberglass spires for a house of worship: received spring 2024
  - Remove deteriorated elements: done
  - Fabricate very long-lasting fiberglass replacements: fall
     2024 thru winter 2025
  - Install fiberglass replacements: spring/summer 2025


